<b>Criteria 1 : Looked after and Previously Looked After Children</b>	A looked after child or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements or special guardianship order will be given first priority in oversubscription criteria ahead of all other applicants in accordance with the School Admissions Code 2021. This also includes those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (as defined in Section 22(1) of the Children Act 1989).
<b>Criteria 2 : Local</b>	Children permanently residing in the priority admission area of the Parishes of Ingatestone, Mountnessing and Margaretting will be asked to provide evidence at a later date. <b>Or:</b> Children attending Ingatestone and Fryerning Junior School, Margaretting and Roxwell Primary Schools (part of the Life Education Trust) or Mountnessing Primary School and on roll for Year 6.
<b>Criteria 3 : Sibling</b>	Children with a brother or sister attending the school at the time of their application and where there is a reasonable expectation that the older sibling will still be in attendance at the time that the younger child is admitted.
<b>Children of staff at Anglo European School</b>	a) Where the member of staff has been employed at the school for two or more years at the time at which the application to the school is made, and/or b) The member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage.
